His cases have been featured in the Wall Street Journal, the New York Times, the Financial Times, the San Jose Mercury News, Politico, Law360, Patently-O, and IP Watch Dog. Brian has worked on cases involving legal issues of national importance, including two patent infringement cases resulting in landmark rulings by the U.S. Supreme Court.

Formerly a partner in the intellectual property group of an Am Law 100 law firm, Brian has represented clients in more than three hundred patent cases. As an oral advocate, he has argued Markman hearings for more 20 patents, over two dozen PTAB arguments, and half a dozen CAFC oral arguments.
